

AFFIDAVIT

I, the undersigned,

HERCULES DU PREEZ WESSELS,

do hereby make oath and state:



- 1 I am a duly admitted attorney, practising as such at Cullinan & Associates Inc, with offices at 18A Ascot Road, Kenilworth, Cape Town. I am the First and Second Applicants' attorney of record in this matter.
- 2 The contents of this affidavit are true and correct. Unless I indicate otherwise, or the contrary appears from the context, they are within my personal knowledge and belief.
- 3 The purpose of this affidavit is to provide sufficient proof for purposes of enabling this Court to establish and satisfy itself that the respondents received adequate notice of the applicants' application set down for hearing on 12 July 2022, and that the respondents are aware of the applicants' aforementioned application.
- 4 On Thursday 7 July 2022, our office received confirmation from the First to Fifth Respondents' ("the **LLPT**") attorneys of record that they will accept electronic service of the application and also physical service of the application at the address of their offices. Attached as "**HW1.1**" is a copy of the email from Mr Peter Rogers of Norton Rose Fullbright confirming that they will accept electronic service.
- 5 On Friday 8 July 2022, the attorneys for the Sixth Respondent ("the **City**"), Webber Wentzel, also confirmed that they will accept electronic service of the applicants' application. Attached a copy of the aforementioned email, as "**HW1.2**". Subsequently, the State Attorney for the Seventh Respondent ("the **Province**") also confirmed that it will accept electronic service. Attached a copy of the aforementioned email from the State Attorney, as "**HW1.3**".



- 6 Between 12h30 and 13h00 on 8 July 2022, the application was issued at this Court, and shortly thereafter, Mr Cormac Cullinan of our office tended to the electronic service of the application on all of the respondents, at 13h40, on the same day, as is evidenced by the email attached as "**HW2**". On the same day and after Mr Cullinan served the application electronically on the respondents:
- 6.1 at 14h42 the Province's attorney confirmed receipt of the application, as is evident from the email from the State Attorney annexed as "**HW3**";
- 6.2 at 15h01 Mr Rogers on behalf of the LLPT confirmed receipt of the application, as is evident from the email from Mr Rogers annexed as "**HW4**"; and
- 6.3 At 17h04 Ms Sabrina De Freitas of Webber Wentzel confirmed receipt of the application on behalf of the City, as is evident from the email from the Ms De Freitas annexed as "**HW5**".
- 7 On the same day and subsequent to the application being issued at Court, I attended the office of the sheriff of Cape Town West to provide the Sheriff of this Court with the instruction to physically serve, and on an urgent and same day basis, a copy of the application on the LLPT, the City and Province, who's service addresses are all within its jurisdiction. However, the Sheriff does not take new instructions for same day urgent service after 13h00, and therefore I was informed that the instructions will be executed on Monday, 11 July 2022. I attach a copy of the stamped instruction letter as "**HW6**", which shows that the instruction was given to the sheriff on 8 July 2022.

8 As our office did not receive a confirmation of receipt of the electronic service of the application from the Eighth Respondent's ("the FNC") attorney, being Mr Deon Petersen of Basson & Petersen Attorneys Inc, in the afternoon of 8 July 2022 I contacted his office and his mobile to ascertain whether or not he received the application. I also sent him various text messages for purposes of bringing the application to his attention. On 9 July 2022 and at 08h28, Mr Petersen confirmed receipt of the application which was served on him electronically. Attached as "HW7", is proof of Mr Petersen's confirmation of receipt of the application. I also confirm that on the morning of 11 July 2022, the Sheriff of Belville was instructed to serve a copy of the application on an urgent same day basis at the office of Mr Petersen. Attached a copy of the stamped instruction letter, to the Sheriff, as "HW8".

9 In the circumstances, I submit that all of the respondents' have received adequate notice of the application and has knowledge of the application, this is evidenced by the confirmation of receipts by their respective legal representatives. I also submit that the application was brought to the attention of the respondents as fast as possible and shortly after the application was issued at this Court. The fact that the respective sheriffs will serve the respondents with the application today (i.e. 11 July 2022) does not prejudice the respondents since they received a copy of the application on the afternoon of 8 July 2022.
